Schedule "A"

Local Law #1_ of the Laws of 2017

Be it enacted by the Village Board of Trustees of the Village of Hoosick Falls, New York as follows:

Section 1. Boarding of Vacant Buildings.

- A. Every person(s), limited liability corporation, corporation, banking institution or trust owning or having control of a vacant building shall lock, board or otherwise secure all windows, doors and openings on each and every floor and basement of the building to restrict entry by unauthorized persons.
- B. A vacant building that is boarded pursuant to this section shall be boarded by using one half (1/2) inch plywood board. Any board placed on a vacant building shall be painted a color that is consistent with the color of the structure and shall be cut to fit into any windows, doors or other openings on such vacant building.

Section 2. Maintaining of boarded up windows, doors and openings.

It shall be the sole responsibility of the person(s), limited liability corporation, corporation, banking institution or trust owning or having control of the vacant buildings to maintain all boarded up windows, doors and openings.

Section 3. Failure to board up and secure vacant buildings; costs and disbursements payable to the Village.

A. In the event that every person(s), limited liability corporation, corporation, banking institution or trust, after written notice has been served on them that vacant buildings must be secured in a manner prescribed by this Local Law, and have not come into compliance within fourteen (14) days from the receipt of said letter, then and in that event, the Mayor of the Village may order Village employees or independent contractors to board up and properly secure any vacant building and the person(s), limited liability corporation, corporation, banking institution or trust shall be responsible to the Village for the total cost of boarding up and securing those properties not in compliance.

B. In the event that it becomes necessary for the Village to board up and secure any vacant buildings after proper notice has been given to do so, and the person(s), limited liability corporation, corporation, banking institution or trust has failed to make payment to the Village within thirty (30) days of the presentation of a bill for said work by the Village, then and in that event, the Village shall be authorized to add the bill for these repairs to the real property tax levied on that building.

Section 4. Penalties.

The penalty for any person(s), limited liability corporation, corporation, banking institution, or trust for violating this Local Law shall be as follows:

- 1. First offense shall be the sum of one hundred (\$100.00) dollars a day until the violation is remediated.
- 2. Second offense shall be the sum of two hundred (\$200.00) dollars a day until the violation is remediated.
- 3. Third offense shall be the sum of three hundred (\$300.00) dollars a day until the violation is remediated.

Section 5. Severability Clause.

In the event that any section or clause in this Local Law is adjudged to be unconstitutional, then and in that event, it shall be deemed that all other clauses shall remain in full force and effect.

Section 6. Effective Date: This Local Law shall take effect upon filing with the Secretary of State's Office for the State of New York.
